Born-Alive Abortion Survivors Protection Act The Born-Alive Abortion Survivors Protection Act (BAASPA) is a bill to protect the lives of babies born during or after an abortion attempt It insists that doctors must provide the same care as he/she would for any other child born at that same gestational age if an abortion had not been attempted
